### Entry guidelines:

All media, 2D and 3D are encouraged for this show and no larger than 12 inches in any direction. All works must be at Lawrence Street Gallery by Nov. 26th at 5 p.m. All work must be ready for exhibiting & **wired** for hanging. Attach labels to the pieces on the back of framed work or bottom of free-standing work. Size & weight restrictions: **12 inch max width, height, depth**; 50 lbs. max weight.

### All Work Must Be For Sale:

The gallery will take a 30% commission on all sales. Work may be sold and taken by customers before the exhibit end date as this is a holiday show. All prices will remain at the artist's indicated sale price on the entry form.

**Work must not have been previously shown at LSG.**

### Entry Fee:

The nonrefundable show fee of \$25 (cash or checks) is for up to **2 entries**. **No credit charges**. Checks should be made out to Lawrence St. Gallery.

### Entry Procedure:

Bring in up to 2 pieces, this entry form, a Self-Addressed, stamped business-size envelope, and the \$25 entry fee to: Lawrence St Gallery 22620 Woodward, Suite A, Ferndale MI. No later than Nov. 26, 2011 at 5 P.M.

**Juror : Aaron Timlin** is the Executive Director of the Contemporary Art Institute of Detroit, and a past executive Director of the Detroit Artists Market He has served as juror for ArtServe, Rhode Island State Council on the Arts and Anton Art Center. Timlin is President and CEO of the Detroit Land Trust. He has been a speaker and presenter for the Canadian Consulate, WSU, U of M, CMU and CCS.

### Liability:

The Lawrence St. Gallery will exercise professional care in the handling of all entries, but cannot assume liability for loss or damage, however caused, while works are in the gallery's possession or in transit. It is recommended that each artist provide his/her own insurance. All work not claimed within 30 days of the pick-up dates will become the property of the Lawrence Street Gallery. If you cannot claim your unsold art work, you must arrange for another person to do so on the specified pick-up date.
